Afterwards, I decided to search through some of the universities of Australia, in which after considering several factors, I opted the Flinders University for the course – Master of Physiotherapy. To study in Australia, I had to get a remarkable score in an English Proficiency test. Therefore, I appeared for IELTS examination held by IDP on 11th June 2022. The result was published on 25th June 2022. I achieved overall band score of 7.0, with each band; Listening 8.0, Reading 7.0, Writing 6.0 and Speaking 6.0.

WHY NOT INDIA?

After deciding that I will study my post-graduation, I was certain at the same time I was anxious about which specialization to opt, meanwhile confusing suggestions from seniors and siblings which was poured into my head put me in confusion to rather pursue my master program in India or Abroad. In India as well all over the world, in any Health Sector it has become basic need to manage its work by having the physiotherapy aspects at its core. Also, when I came across the curriculum of various universities, I observed the monotony in it, as the modules were not revised at certain time period making it obsolete with concern to the industry's requirements. Apart from this, the conventionally formulated master degree programs are not having the blended modules or specializations in Physiotherapy.

Moreover, with average to good academic profile as mine to get admission in top ranked universities, a candidate has to clear respective entrance examinations or G.A.T.E. and apart from that candidate usually requires to fall under superior merit rank, which leads to the vast difference in terms of applications received from candidates and the number of seats. Due to such stringent criteria and limited number of seats, it becomes bottleneck for the students who wants to pursue courses in institutions such as IMS or AIMS, Pilani as well as MPT's and above all considering the financial aspects, tuition at such renowned institutions in India also usually floats around INR 20 to 25 lacs making it unaffordable as well taking the global ranking in to account even after paying such hefty amount, having a backdrop of not being exposed to internationally recognized course and university which comes under top 250 universities in terms of global presence.

Moreover, after receiving the feedback from the graduated students as well as working professionals, I came to know that limiting myself with only theoretical concepts of Health sector would not help me to achieve this proficiency to achieve my goals in India, also considering the overall expenses and affordability of master program in India or any other commonwealth country overall comes under the affordability by any family who is well-settled in India. Moreover, restraining my cultural development in monotonous manner by pursuing course in India would hinder my social awareness to be globally responsible person which would allow me to fit my frame in any organization's requirement. Hence, I finally took the decision to study abroad because if I really wanted to learn what is needed to be, it won't be possible with the chaos present in our education system with regards to this subject.

WHY AUSTRALIA?

Australia is one of the biggest hubs for international students for its globally recognized degree and quality education that gives equally importance to theoretical knowledge and its practical implementation. Initially, I referred the USA's educational institutions where I found that most of the 2-year master programs are being offered where the per annum tuition for median universities ranging around USD 18000 to 22000 excluding the living expenses of around USD 12000 per annum which would extensively put strain on my parental finances. Onwards, considering the UK Universities, which offers short-term master degree programs with around GBP 15000 to GBP 18000 per annum with more management modules approach over the core respective field focused programs and Canadian Universities are having significantly higher per annum tuition and most of the public institutions are offering post-graduation diploma whereas Australia is having well-crafted master degree programs especially in the domain of Physiotherapy along with allied fields. Moreover, the weather conditions are similar to Indian ocean region which would not put me in the situation of sudden climate shift may result into unnecessary living hardship affecting the educational progression.

Apart from this, Australia has third highest number of international students in the world and offers vast number of world-renowned colleges and universities providing wide variety of globally recognized courses and degree one can choose a field more focused on their interest. After detailed research and discussion with lots of people regarding my higher studies, I found that Australia is the best place to pursue higher education. The education system in Australia is recognized worldwide and maintains a high standard. Pursuing a Master's degree from one of the universities in Australia will not only boost my career, but it will also help me grow intellectually.
